



# Sandown Racing Club

## I WOULD LIKE TO BECOME A MEMBER OF SANDOWN RACING CLUB AND I UNDERSTAND, REPRESENT AND AGREE AS FOLLOWS:

1. I understand that the purpose of Sandown Racing Club is to provide the experience of Thoroughbred racehorse ownership through participation in a partnership that races Thoroughbred racehorses.
2. I understand that the Club is organized as a partnership. I understand that any potential return on my investment is dependent upon how well the Club's horses perform. Under no circumstances will there be any further charges over and above the initial membership fee, save for the GPEB license fee of \$30 that is valid for three years. (see 5 below)
3. As to Club activities, I understand that:
  - a) Sandown Racing Club has acquired by way of lease the horses Future Games, Sprog and Big Time Louie with the intention to race them for the 2019 season;
  - b) Up to 200 memberships in the Club will be sold at \$250.00 each and each Membership will constitute a 1/200<sup>th</sup> share in the Club. Funds raised from selling memberships will be used towards stabling, veterinarian, blacksmith and training fees and other expenses;
  - c) All racing and training decisions will rest with the Trainer and Club Manager;
  - d) As the horses are owned by a separate entity created for that purpose and leased to the Club, members will bear none of the risks associated with owning or buying the horses. However, members will be entitled to purse winnings and will receive their share after October 31, 2019 net of such training, Club management and other costs involved in maintaining the horses that are not covered by the membership fees;
4. I represent to the Club, the BC Gaming Policy and Enforcement Branch (GPEB), and any other regulatory bodies, that I am eligible to receive an owner's license. I understand that a GPEB license is required to own a racehorse, and therefore to participate in Sandown Racing Club and I agree to pay the ownership license fee. I understand that if I am denied a GPEB

license, I will be denied membership in Sandown Racing Club and my membership fees will be returned.

5. I agree that this is the only agreement or understanding that applies to my interest in Sandown Racing Club.
